UNIVERSITY OF COLORADO BOULDER SOFTWARE LICENSE FOR NONCOMMERCIAL RESEARCH USE

The Regents of the University of Colorado, a body corporate, for the University of Colorado Boulder, having as office at 4845 Pearl East Circle, Suite 200, Boulder, Colorado ("University") is making available the AMGeO software package to you, the "Licensee", at no charge under the terms of this License.

The Licensee's installation and use of the Licensed Software is subject to the terms and conditions of this License. By downloading, copying, installing, or otherwise using the Licensed Software, the Licensee agrees to be bound by the following:

GENERAL TERMS AND CONDITIONS

Article 1 **Definitions**

- 1.1 **Definitions**. The terms defined in the Preamble have their assigned meanings and the following terms, whether used in the singular or plural, have the meanings assigned to them.
 - (a) "AMGeO Collaboration" means the Lead Authors and any additional authors of the Licensed Software.
 - (b) "AMGeO Web Services" means the API web application software served on University computing resources that is accessible by internet connection to University servers and that enables the Licensed Software to obtain data from Third Party Data Services.
 - (c) "AMGeO Website" means https://amgeo.colorado.edu or any subsequent web address where University hosts the official website for the Licensed Software.
 - (d) "Commercial Purposes" means (i) the sale, lease, license, or other similar transfer of the Licensed Software or any Derivative Work to any third party for any fee, rate, charge, or other consideration; (ii) the sale, lease, license, or other similar transfer of any data, datasets, forecast or other predictive models generated as output by the Licensed Software or any Derivative Works for any fee, rate, charge, or other consideration; or (iii) the use of the Licensed Software or any Derivative Work to perform contract services. Commercial Purposes does not include industry sponsored academic research, which means research sponsored by a for-profit carried out at a non-profit organization and by the non-profit organization's employees.

- (e) "**Derivative Work(s)**" means any work developed or made that would be characterized as a derivative work of the Licensed Software, in whole or in part, under 17 U.S. Code § 101. For clarity, new versions of the Licensed Software are a Derivative Work.
- (f) "Lead Authors" means Tomoko Matsuo and Liam Kilcommons at the Colorado Center for Astrodynamics Research (CCAR) and the Department of Aerospace Engineering Sciences at the University of Colorado Boulder.
- (g) "License" means this University of Colorado Boulder Software License for Noncommercial Research Use.
- (h) "Licensed Software" means the software files and related documentation identified as the AMGeO software package for the assimilative mapping of geospace observations with data obtained from Third Party Data Services and related to University Case Number CU4574B. The Licensed Software was initially developed and continues to be developed by the AMGeO Collaboration with funding from the NSF.
- (i) "**Licensee**" means the individual that downloads, copies, installs, or otherwise uses the Licensed Software.
- (j) "Licensee Data" means data in electronic form input or collected by University from the Licensee in conjunction with the Licensee's downloading, installation, and use of the Licensed Software and includes data that the Licensee submits to University to create the Licensee's user account and data collected by University through the Licensee's use of the Licensed Software.
- (k) "Open Source Materials" means any software, library, utility, tool, or other computer or program code that is made available or distributed in source code form, including, but not limited to, any code licensed or distributed under the GNU Lesser Public License (LGPL), Mozilla Public License (MPL), BSD licenses, the Artistic License, the Netscape Public License, the Sun Community Source License (SCSL) the Sun Industry Standards License (SISL), or the Apache License.
- (l) "SuperDARN" means the Super Dual Auroral Radar Network operated by the SuperDARN Research Group at Virginia Tech in collaboration with Dartmouth College, University of Alaska Fairbanks, and the Johns Hopkins University Applied Physics Laboratory.

- (m) "SuperMAG" means the SuperMAG worldwide collaboration of organizations and national agencies that operate ground based magnetometers.
- (n) "Third Party Data Services" means SuperDARN, SuperMAG, and any other third-party data service that may be utilized or accessed by the Licensed Software.

Article 2 Use of the Licensed Software

- 2.1 **License**. Subject to the terms and conditions of this License, University hereby grants to the Licensee, under University's rights in the Licensed Software, a worldwide, non-exclusive, royalty-free, fully paid-up license to use, reproduce, distribute, transmit, create Derivative Works of, publically display and publically perform the Licensed Software for non-profit educational, research, and academic purposes only.
- 2.2 Licensee Created Derivative Works. Derivative Works created solely by the Licensee for non-profit educational, research, or academic purposes, including any copyrights or other intellectual property rights in such Derivative Works, are owned solely by the Licensee. The Licensee hereby grants to University a non-exclusive, royalty-free, fully paid-up license to use, reproduce, transmit, perform, and distribute internally Licensee-created Derivative Works solely for University's own internal use, or for educational and research purposes of University. The Licensee shall deliver to University at least once per calendar year a current copy of all Licensee-created Derivative Works.

2.3 Restrictions.

- (a) The Licensee may not use the Licensed Software for any Commercial Purposes. The Licensee shall not sell, license, or transfer the Licensed Software, or any work that in any manner contains the Licensed Software, for a fee.
- (b) The Licensee shall not: (i) use the Licensed Software in any way to allow third parties to exploit the Licensed Software; (ii) provide passwords or other log-in information to any third party; (iii) access the Licensed Software in order to build a competitive product or service, to build a product using similar ideas, features, functions or graphics of the Licensed Software, or to copy any ideas, features, functions or graphics of the Licensed Software. In the event that University suspects any breach of the requirements of this Section 2.3, University may suspend the Licensee's access to the Licensed Software without advanced notice, in addition to such other remedies as University may have. Nothing in this License requires University to take any action against the Licensee or any third party for violating

this Section 2.3 or this License, but University is free to take any such action it sees fit.

- 2.4 **Limitation on Rights**. This License confers no license or rights by implication, estoppel, or otherwise under any intellectual property rights of University other than the Licensed Software.
- 2.5 **Attribution**. In any publication of the results of research performed using the Licensed Software or any Derivative Work, the Licensee shall, as appropriate, provide attribution to the AMGeO Collaboration and a reference to the appropriate digital object identifier (DOI) for the version of the Licensed Software used.
- 2.6 **Proprietary Notices**. The Licensee shall not remove or modify the copyright, trademarks, or other proprietary notices and disclaimers as they appear in the Licensed Software or in the output materials generated by the Licensed Software, and shall keep intact all notices in the Licensed Software that refer to this License. Notwithstanding the foregoing sentence, to the extent that the Licensee creates a Derivative Work that no longer accesses the AMGeO Web Services, then the Licensee shall remove all University copyright, trademarks, and other proprietary notices from the output materials generated by the Derivative Work.
- 2.7 **Use of University's Name**. Except as allowed under Sections 2.5 and 2.6, above, the Licensee shall not otherwise identify University or the AMGeO Collaboration in any promotional advertising, press releases, sales literature or other promotional materials to be disseminated to the public or any portion thereof without the prior written consent of University in each case. Licensee further shall not use the name of University or any University faculty member, author, employee, or student or any trademark, service mark, trade name, copyright, or symbol of University, without the prior written consent of University or the person whose name is sought to be used.
- 2.8 **No University Obligation to Provide Technical Support**. University has no obligation to provide technical support to the Licensee, by telephone, email or otherwise, including but not limited to modifications, improvements, customizations, patches, or bug fixes for the Licensed Software or any Derivative Works. The Licensee is solely responsible for obtaining any technical support.

Article 3 Redistribution

3.1 The Licensee may reproduce and distribute the Licensed Software and Derivative Works provided that the Licensee meets the following conditions:

- (a) The Licensee must give any recipients of the Licensed Software or Derivative Works a copy of this License;
- (b) The Licensee must cause any modified files to carry prominent notices stating that Licensee changed the files from the original Licensed Software files provided by University;
- (c) The Licensee may not remove from the source code form of any Derivative Works that the Licensee distributes, any copyright, patent, trademark, or attribution notices included or incorporated in the Licensed Software; and
- (d) The Licensee may add the Licensee's own copyright statement to the Licensee's modifications and may provide additional or different license terms and conditions for use, reproduction, or distribution of the Licensee's modifications, or for any such Derivative Works as a whole, provided the Licensee's use, reproduction, and distribution of the Licensed Software otherwise complies with the conditions stated in this License.

Article 4 AMGeO Web Services and Third-Party Data Services

4.1 **Registration with Third-Party Data Services**. In order to use the Licensed Software, the Licensee may be required to register an individual account with a Third-Party Data Service. To the extent such an individual account is required to access any Third-Party Data Service as part of the operation of the Licensed Software, the Licensee will be prompted to insert a username and password specific to the relevant Third-Party Data Service upon installation of the Licensed Software. University does not store this username or password information, but the username and password are stored locally on the Licensee's hardware on which the Licensed Software is installed. The Licensee's use of its individual account to access the Third-Party Service is subject to the terms and conditions of the Third-Party Service.

4.2 AMGeO Web Services.

(a) Access to the AMGeO Web Services. In order for the Licensee to use the Licensed Software, the Licensed Software must access the AMGeO Web Services. At the time that the Licensee is provided access to download the Licensed Software, the Licensee will be provided an API Key from University that allows the Licensed Software to access the AMGeO Web Services. The Licensee must insert the API Key into the required field the first time that the Licensee installs the Licensed Software. This API Key is personal to the Licensee and may only be used by or on behalf of the Licensee to use the Licensed Software. The Licensee may not share the API Key with any third party and shall

- take reasonable steps to prevent unauthorized use of the API Key. The Licensee shall notify University immediately of any known or suspected unauthorized use of the Licensee's API Key and shall use best efforts to stop the unauthorized use.
- (b) Sharing of Licensee Data Associated with the Licensee's API **Key**. University uses the API Key to track the number and frequency of data requests from the AMGeO Web Services and Third-Party Data Services by the Licensee. University may report the number and frequency of data requests by Licensee to third-party funders who have funded or are currently funding University's development of the Licensed Software, but only in the aggregate with the number and frequency of data requests of all users of the Licensed Software. University may also report the number and frequency of data requests for a specific Third-Party Data Service to the Third-Party Data Service provider, but only in the aggregate with the number and frequency of data requests for the specific Third-Party Data Service of all users of the Licensed Software. For purposes of this Section 4.2(b), reporting in the aggregate means that any data that is reported will have the following removed: personally identifiable information, including Licensee's name and email address.
- (c) University's Use of Licensee Data Associated with the Licensee's API Key. University's use of the Licensee's number and frequency of data requests is governed by Article 5, below, and any privacy policy published on the AMGeO Website.

Article 5 Licensee Data and Privacy

- 5.1 Use of Licensee Data Associated with the Licensee's API Key. University's use of the Licensee Data associated with the Licensee's API Key is governed by Section 4.2(b), above, this Article 5, and any privacy policy published on University's AMGeO Website.
- 5.2 Use of Licensee Registration Data. Before the Licensee was allowed to download the Licensed Software, the Licensee was required to register with University the Licensee's name, affiliated research institution, and an email address maintained by the affiliated research institution and to create a username and password. This information provided by the Licensee will be associated with the Licensee's API Key. University will use this Licensee Data only as necessary to provide the Licensed Software to the Licensee, including as necessary to maintain the Licensed Software and provide technical assistance to the Licensee.
- 5.3 Except as set forth in this Article 5 or Section 4.2(b), unless it receives the Licensee's prior written consent, University: (a) shall not access, process, or

otherwise use Licensee Data other than as necessary to facilitate the Licensee's use of the Licensed Software; and (b) shall not intentionally grant any third party access to Licensee Data, except subcontractors that are subject to a reasonable nondisclosure agreement. Notwithstanding the foregoing, University may disclose Licensee Data as required by applicable law or by proper legal or governmental authority. University shall give the Licensee prompt notice of any such legal or governmental demand and reasonably cooperate with the Licensee in any effort to seek a protective order or otherwise to contest such required disclosure, at the Licensee's expense. University is subject to the Colorado Open Records Act (C.R.S. 24-72-201, et seq.). Licensee Data shall be treated by University as confidential to the extent permitted by law.

Article 6 Intellectual Property Rights

6.1 **Title to Licensed Software**. Except for any Open Source Materials, University retains all right, title, and interest to the Licensed Software, including all copyrights, trademarks, and other intellectual property rights in the Licensed Software and in all graphics, user interfaces, logos, and trademarks reproduced through the Licensed Software.

- AGAINST CLAIMS RELATED TO INFRINGEMENT OF INTELLECTUAL PROPERTY; AND (ii) UNIVERSITY DOES NOT REPRESENT OR WARRANT THAT THE LICENSED SOFTWARE WILL PERFORM WITHOUT INTERRUPTION OR ERROR.
- Co Third-Party Data Services. Your access and use of the Third-Party Data Services is subject to the terms and conditions of the Third-Party Data Service provider. UNIVERSITY MAKES NO REPRESENTATIONS, EXTENDS NO WARRANTIES OF ANY KIND, EITHER EXPRESS OR IMPLIED, AND ASSUMES NO RESPONSIBILITIES WHATSOEVER WITH THE RESPECT TO USE, INABILITY TO USE, OR THE RESULTS OF USE, OF THE THIRD-PARTY DATA SERVICES.
- (d) AMGeO Web Services. The AMGeO Web Services serves data obtained from third-party providers. UNIVERSITY MAKES NO REPRESENTATIONS, EXTENDS NO WARRANTIES OF ANY KIND, EITHER EXPRESS OR IMPLIED, AND ASSUMES NO RESPONSIBILITIES WHATSOEVER WITH THE RESPECT TO USE, INABILITY TO USE, OR THE RESULTS OF USE, OF THE AMGEO WEB SERVICES.
- (e) Nothing in this License may be construed as
 - (i) A warranty or representation by the University as to the validity or scope of any of the rights included in the Licensed Software or Derivative Works;
 - (ii) A warranty or representation regarding the use or the results of the use of the Licensed Software in terms of their correctness, accuracy, reliability or otherwise; or
 - (iii) An obligation to furnish any know-how or services not agreed to in this License.
- (f) Open Source Materials. The Licensed Software was designed to function with the use of libraries developed from Open Source Materials, and the Licensed Software may be subject to the terms and conditions governing the use of such Open Source Materials. The Licensee is bound by the terms and conditions for the applicable Open Source Materials and is solely responsible for compliance with such terms and conditions. 7.2 Limitation of Liability. Article 8 General

8.1 Termination.

- (a) The Licensee's rights under this License will terminate automatically, without notice from University, if the Licensee fails to comply with any terms of this License. Upon termination of this License, the Licensee shall cease all use of the Licensed Software and Derivative Works.
- (b) If the Licensee does not use the Licensed Software for a three-year period, University shall suspend the Licensee's access to the Licensed Software, without notice from University. If the Licensee thereafter wishes to use the Licensed Software, the Licensee must create a new account with University and must reinstall the Licensed Software and input a new API Key.

- 8.4 **Governing Law and Venue**. This License is governed by and will be construed in accordance with the laws of the State of Colorado without giving effect to any choice of law principles that would require the application of the laws of a

different jurisdiction. Any disputes under this License may only be brought in the state or federal courts located in Colorado.

- 8.5 **Entire Agreement**. The terms and provisions contained in this License constitute the entire agreement between the parties with respect to the subject matter of this License and supersede all previous communications, representations, agreements or understandings, either oral or written, between the parties hereto with respect to the subject matter of this License.
- 8.6 **Technology Export**. The Licensee shall not: (a) permit any third party to access or use the Licensed Software in violation of any U.S. law or regulation; or (b) export any software provided by University or otherwise remove it from the United States except in compliance with all applicable U.S. laws and regulations. - 8.7 **Government Rights.** The Licensed Software was developed under a funding agreement with the Government of the United States of America and may be subject to all of the terms and conditions of 48 C.F.R. 52.227-19 and 48 C.F.R. 252.227-7013. University may amend this License from time to time by posting an amended version at the AMGeO Website and sending the Licensee written notice thereof, which written notice may be by email sent to the email address that the Licensee submitted to University when setting up its user account.

Such amendment will be deemed accepted and become effective 30 days after such notice unless the Licensee first gives University written notice of rejection of the amendment. In the event of such rejection, the License will automatically terminate without any additional notice from University, and the Licensee shall cease all use of the Licensed Software and Derivative Works. The Licensee's continued use of the Licensed Software or any Derivative Work following the effective date of an amendment will confirm the Licensee's consent to the amendment. This License may not be amended in any other way except through a written agreement by authorized representatives of each party. Notwithstanding the foregoing provisions of this Section 8.11, University may revise the privacy policy at any time by posting a new version at the AMGeO Website, and such new version will become effective on the date it is posted.
